



**DIVE TRAVEL/TOUR CONTRACTUAL AGREEMENT**

1. I UNDERSTAND THAT THE PURPOSE OF SIGNING THIS DOCUMENT IS TO ENTER INTO A CONTRACT WITH DIVER’S DREAM CHARTERS, INC. FOR THE PURPOSE OF CHARTERING THE P/V LU-JAC’S QUEST FOR THE STATED PURPOSE ACCORDING TO THE AGREED UPON PRICE AND DURATION.
2. **A \$500 deposit is required when a reservation is made (full refund if cancelled more than 14 days in advance, 50% refund cancelled 7-13 days in advance, 25% refund if cancelled with less than 7 days’ notice, and nonrefundable if cancelled within 48 hours of departure.**
3. Full payment is required upon departure; we depart from and return to Anacortes, any other arrangement subject to a relocation fee. Sales tax is additional, except as noted. Scuba divers are required to sign a standard liability release form, and to show proof of advanced open water certification.
4. **For a multi-day booking**, we will need the first day's charter cost as a non-refundable deposit.
5. You are purchasing a personalized service and space is limited. If you have trouble filling the spaces after you reserve, please let us know as soon as possible. We will work with you to advertise the trip if possible, or fill your space with other clients.
6. For independent Dive Masters/Instructors not affiliated with a shop the minimum price is \$600 (min 6 divers) and the dive master comes free with proof of insurance. Any divers beyond 6 people it is \$100 per head. This includes sales tax.
7. Dive Masters and Dive Instructors will provide a copy of their current insurance which lists Diver's Dream Charters as additional insured.
8. By way of my signature on this contract I am agreeing to keep the Owner and Captain of P/V Lu-Jac’s Quest informed of this booking by calling 360-202-0076 or e-mailing through the web page at [www.lujacsquest.com](http://www.lujacsquest.com) if changes or problems arise.
9. My signature on this document affirms that I agree to:
  - a. Provide a copy of my current insurance naming Diver’s Dream Charters, Inc. as additionally insured on my insurance policy.
  - b. Collect the money and pay with one check, money order or cash.
  - c. Verify the experience level of the person or persons going on the trip to know they can dive cold water, NW Washington waters and the conditions we experience in the San Juan’s.
  - d. Have current DAN O2 training and current first Aid/CPR training.
10. I HAVE READ AND UNDERSTAND THE FOREGOING IN ITS ENTIRETY AND I AGREE TO THE TERMS AND CONDITIONS HEREIN AND ABOVE SET FORTH ON BEHALF OF MYSELF, MY HEIRS AND MY PERSONAL REPRESENTATIVES. I REALIZE THAT THIS IS A CONTRACT AND THAT IN CONSIDERATION OF THIS AS AN INSURED DIVE MASTER/INSTRUCTOR, I GET TO DIVE FREE OF CHARGE.
